Pre-registration entries must be received by October 6th, 2023. Cancellations after October 13th will **NOT** be refunded. There will be no rain-delay dates for these matches. Pre-registration fees will be returned in the case of match cancellation.

Pre-Registration gets priority squadding. Competitors may register on the day of the

match and be worked in first come first serve.

Out of State Competitors must be TSRA members. If a member of their home state's

rifle association (not NRA) they may purchase a 3 day pass. If not then a

normal TSRA membership is required.

A release must be on file with the CMP for all competitors

TRPC Liability Release:

A release must be on file with TRPC for all competitors. Forms available at check-in.

Fees:

3 Rifle Aggregate - State Vintage Champion (new this year):

\$65 adult (junior \$50) (Garand/Springfield/Vintage)

or

Rifle Individual: \$30 (juniors \$20) for first match

\$25 for each additional match including 3 Rifle Aggregate entries

(juniors \$15)

or

Rifle 5 Match Special: \$100 adult (junior \$75)

Discount for any competitor shooting 5 rifles in any combination

of rifle types and re-entries (no special award given)

Pistol/Revolver EIC: \$25 per match (adult / junior both)

RULES

Current CMP Games Competition Rules for Rifle and Pistol will govern. Competitors are responsible for being aware of the Match Program and all safety regulations contained in the CMP rulebook or announced at the morning safety briefing.

<u>Squadding:</u> All matches will be squadded on the firing line.

Scoring Terrell Rifle and Pistol Club does not have pits. Competitors will score and paste targets

between each string of fire.

<u>Challenges:</u> A \$2 Challenge Fee will be charged for lost challenges. Scores may only be challenged

prior to awards.

Targets: Rifle: 200 yd SR

Carbine: 100 yd SR1

Pistol / Revolver: NRA B-8 50 yd and NRA B-16 25 yd

Rifles: Rule 4.2.1 General Requirements

As-Issued M1 Garand Rule 4.2.2 Unlimited M1 Garand Rule 5.2.6

Springfield Rule 4.2.3

Vintage Military Rule 4.2.4 / 4.2.5

Modern Military Rule 5.2.2 / 5.2.3 / 5.2.4 /5.2.8

<u>Pistols:</u> Service Pistol: Rules 4.1.1

Rimfire Pistol: Rule 4.1.2 Service Revolver: Rule 4.1.3

Ammo: Will not be provided (may be purchased). Ammunition must be safe. Any defective or

unsafe ammunition will be removed from the firing line. Any competitor that cannot get/

stay on target will be removed from the firing line.

<u>Chamber Flags:</u> The use of an empty chamber indicator (ECI) is always required even while the rifle is in

the case. Only during a preparation period or actual firing may the ECI be removed from

the rifle.

Magazines: Magazines and loading blocks may only be inserted in the rifle during the preparation

period or live firing.

<u>Level Loading:</u> Level-loading is required. Rifles must be pointed at the impact berm or lower while

closing the bolt.

<u>Coaching:</u> Coaching is not allowed unless helping a "new" shooter.

Mobile Phones: Cellphone use is prohibited when firing or scoring. Use of cell phone to keep time is

permitted only when "cellular data" is turned off, i.e., the phone is in airplane mode.

<u>Challenge Period:</u> The challenge period will be 30 minutes after the completion of each match. All awards

and scores are tentative until publication of the official match results. The Statistics

Officer will resolve all protests.

<u>Coaching:</u> Coached competitors are not eligible to win State Championships

Brass: All brass must be policed.

Eye & Hearing Protection:

CMP Rule 3.6.2 - All competitors and competition officials, including Scorers or Verifiers, are required to wear eye and hearing protection when on shooting range firing lines during highpower rifle firing. See the CMP rule book for further specifics on eye protection dimensions and proper wear.

TRPC Range Rules:

Everyone on an active range/bay/field must use eye and ear protection.

Guests and minors under 18 must be always supervised by an adult member.

All rifles must be zeroed before firing on the 100 and 200 yard ranges; zero your rifle on a shorter range before moving to a longer one.

AWARDS

Games Matches:

The winner of the As-Issued Military Rifle 3 Rifle Aggregate as defined by Rule 4.6.8 (As-Issued Garand + 1903/A3 Springfield + Vintage Military Rifle) will be the **Overall TSRA State Vintage Champion**.

Note: Do not have to be a Texas resident.

Only 1st entry counted for the Championship Must have 5 competitors to award a plaque.

Plaques will be mailed to winner after the match or winner can choose cash equivalent.

equivalent

The match winner for each rifle type will be the **TSRA Champion** for that event (**Garand, Unlimited Garand, Springfield, Vintage, M1 Carbine, Modern and Unlimited Modern Military**).

Note: Do not have to be a Texas resident.

Only 1st entry counted for the Championship Must have 5 competitors to award a plaque.

Plaques will be mailed to winner after the match or winner can choose cash equivalent.

Marine Corps League entries will automatically be entered in Unlimited Modern Military and are eligible for awards in that class, provided they are TSRA members in good standing.

Achievement pins will be given for competitors who qualify according to the Annex H in the current CMP Games Rules.

EIC Pistol and Revolver Matches:

CMP Medals for first, second, and third place winners will be mailed by CMP after CMP reviews the scores.

EIC Credit Points (Legs) will be determined and awarded by the CMP pending the review of match results.

Achievement pins will be given for competitors who qualify according to the Table 2 in the current CMP Pistol Competitions Rules.

Final Results:

Results from all matches will be posted on the both the Terrell Rifle and Pistol Club website and TSRA's website.
